### **Grindz Team General Policies & Rules**

1. Team members **WILL ALWAYS** conduct themselves appropriately, display good sportsmanship and bring positive exposure to Grindz. Failure to do so will be grounds for removal from the team. \_\_\_\_\_
2. Team members **WILL NOT** use illegal substances or engage in illegal activities. Grindz has a **ZERO TOLERANCE** policy for drug use and crime. If Grindz suspects that use of illegal substances has occurred, they reserve the right to conduct screening for such substances. This will only be done with the written consent of the team member and the team member's parent/guardian if under 18. Refusal will be grounds for removal from the team. \_\_\_\_\_
3. Smoking and Alcohol use is not permitted by adult team members at competitions, skateparks, while in the presence of underage team members or at anytime while representing Grindz. Underage team members are forbidden from smoking and alcohol use by law. \_\_\_\_\_
4. No profanity is permitted by team members...Always set a good example.
5. **NO TRASH TALKING!** It stops with you! \_\_\_\_\_
6. Team members will wear a helmet **ANYTIME** they are on a skateboard, bike, or scooter. \_\_\_\_\_
7. Team members **WILL NOT** get involved in altercations or fights. You may, of course, defend yourself as necessary, or break up a fight if you can do so safely, but generally, if a fight starts go the other way and tell an event official or other adult. \_\_\_\_\_
8. Team members are expected to cooperate with, and show respect towards public safety (police, fire & paramedics, etc) and event officials.
9. Team members will turn in a signed registration form and the appropriate registration fee no later than 10 days prior to each scheduled comp.
10. Team members are expected to participate in every local comp, attend all scheduled practices and participate in all team events. Failure to attend practice regularly, missing 2 consecutive local comps, or failure to notify the team manager that you will not make a comp you are signed up for are grounds for dismissal from the team at the team manger's discretion.
11. Team members will get one new team deck for the comp they are signed up for and will receive it no EARLIER than 48 hours prior to the comp. If deck is broken before the comp, team member will be responsible for purchasing a replacement deck for the comp. If deck is issued and team member does not compete they will have to save the deck for the next comp.
12. Team shirts will be provided and must be worn during the comp. If a team member arrives at the comp without a team shirt, a replacement shirt must be purchased to compete. All team members will wear a team shirt for the duration of each competition – **NO EXCEPTIONS.**
13. If a rider has other sponsors, those sponsors may put 1 sticker on riders helmet, shirt and deck. No stickers can cover the Grindz logo at any time. Grindz must be notified of a team members other sponsors.
14. Team members will pay their own entry fee to comps. Members who place in top three will receive a gift card to Grindz as follows: 1<sup>st</sup> Place - \$20.00; 2<sup>nd</sup> Place - \$15.00; 3<sup>rd</sup> Place - \$10.00
15. Team members are entitled to a 10% discount at Grindz. This is for their personal use and should not be abused.
16. Team members are responsible for arranging their own transportation to comps, practices and events.
17. Team members must have current health insurance to participate in practices, trips and comps.
18. Team schedules and notices will be posted at [www.grindzteam.com](http://www.grindzteam.com) and on the Grindz Team Myspace page – [myspace.com/grindzskateteam](http://myspace.com/grindzskateteam). Team members are responsible for being aware of this information.

**Grindz Team Out of Town Trip Policies & Rules**

- 19. All General Policies & Rules above apply at all times; In Addition, the following apply to Out of Town Trips
- 20. Any team member wishing to travel to an out of town event with the team must sign an Out of Town Trip Form and trip specific Release of Liability Form. If the team member is under 18 a parent/guardian must sign the forms as well. For team members under the age of 18, the Team Manager or other adult representative of the team may want to talk to the parent before the trip to ensure that they are aware of the schedule and events being planned.
- 21. For overnight trips at least one parent of a traveling team member will travel with the team.
- 22. There will generally be a team meeting before overnight out of town trips. These meetings will be 100% mandatory for the team member and at least one parent/guardian. \_\_\_\_\_
- 23. All team members will be responsible for all of their own expenses unless otherwise specified on the Out of Town Trip Form. \_\_\_\_\_
- 24. During all out of town travel team members will always use the Buddy System for safety. \_\_\_\_\_
- 25. Team members will never leave the current team location unless specifically approved by the Team Representative or Team Parent traveling with the team.
- 26. Any team member that has a cell phone should keep it on at all times for emergencies. (with parents approval).
- 27. If a team member is injured in any way, the Team Representative or Team Parent will be notified immediately. If neither is readily available, or if the situation calls for it before notifying the Team Representative or Team parent, notify a public safety official (Police, Fire, Paramedics) or Event Staff.
- 28. All team members are expected to keep a copy of the out of town trip form with them at all times while on the trip.

Remember, you are representatives of Grindz and the team all the time. Just because you are not wearing a Grindz shirt or skating with the rest of the team, you will still be known as a member of the Grindz Team. Always conduct yourself in a way that you and the rest of the team can be proud of.
